So far today, we've had Franklin McNeil at ESPN report that Jones was going to pay the fighters who lost their fights tonight their guarantees as a PR move, but now has decided against it because so many of them were so negative toward him. Then on Twitter, when someone wrote to him, "Thanks to Johnny Bones I have no plans tonight," he wrote back, "Thanks to the old man and his knee, I don't either."  
--Tom "Tiny" Lister, who was Zeus in WWF and Puerto Rico for a few pro wrestling matches more than 20 years ago (and a brief WCW comeback), has agreed to plead guilty for conspiring to commit mortgage fraud. According to the plea agreement obtained by TMZ.com, Lister admitted to being one of several individuals who obtained mortgages on four different homes in Los Angeles by use of false information and fraudulent bank statements. In doing so, they collected \$5.7 million, then defaulted on all four loans, costing the lenders \$2.6 million. Lister also admitted to obtaining \$1.1 million in additional loans, which he never paid back, using the properties as collateral. He will be sentenced in September and is facing up to five years in federal prison.

--Bad Left Hook reported Manny Pacquiao is going to fight on 12/8, the same night as UFC's next show on FOX. While not official, there is smoke to that fire. --Birthdays today include Jeff Hardy (35), Mickie James (33) and Tank Toland aka James Dick (32).

--It was 22 years ago today when Bert Assirati, England's biggest star of the 40s and early 50s and allegedly one of the toughest shooters of all-time, passed away at the age of 82. Dale Lewis, a two-time Olympian and NCAA champion who had a strong 17 year career as a pro wrestler, passed away 15 years ago today at 64. Karloff Lagarde passed away five years ago today at 79. (thanks to Georgia Wrestling History.com)

--There was a concept show held today in Newcastle, Australia, but we don't have any reports on it. The show, called Combat 8, puts boxers vs. MMA fighters, headlined by Les Piper of Australia's contender vs. Justin Murray, an MMA fighter. The rules are no kicking, elbows or knees. Only one takedown is allowed per round and there is a 30 second clock on the ground to get a finish. Fights are taking place in a squared cage and they have plans for shows in October and November.

--Go out of your way to watch the video of Hiroshi Tanahashi's IWGP title win over Kazuchika Okada. Tanahashi may be the best all-around in-ring performer combined with being among the most charismatic guys in the business today.

--Ric Flair returns to pro wrestling with an appearance for Mid Atlantic Championship Wrestling on 10/20 in Kannapolis, NC at the A.L. Brown High School.

--David Bautista arrives in Providence on 9/7 to begin promoting his MMA debut, which takes place on 10/6 at the Dunkin Donuts Center. He will be doing a number of personal appearances in the city.
